

## Real Estate & Personal Property Taxes

The Town of Red Cedar will continue to have the Dunn County Treasurer's office collect these taxes. Personal Property Taxes are due to the County by January 31, 2017.

### Did you receive your Lottery and Gaming Credit on your Real Estate Tax Bill?

To qualify you must:

1. Own the property and use that property as your primary residence as of January 1, 2016; or
2. The property was used by the previous owner as a primary residence on January 1, 2016.

If you meet one of these requirements and did not receive the lottery credit, you may claim it by signing and dating the 2016 Lottery and Gaming Credit Application before you pay your 2016 Real Estate Taxes. You may contact the Dunn County Treasurer's Office for further information or to obtain an application form. Please return the completed form to the Dunn County Treasurer's Office.

### Building Inspections/Permits

The Town building inspector is Fred Weber of Weber Inspections. Permits and inspection fees are required for: New residential, heating, air conditioning, ventilating, plumbing, electrical, setbacks, additions, attached porches, garages, inside and outside alterations, room expansions, etc. (This includes where any walls are moved or added, and/or windows are changed or moved, etc.)

If you will be adding a detached garage, pole building, silo, shed, barn, agricultural building, tower, outbuilding, additions to existing structures, decks/porches/sunrooms, greenhouse, garden shed, or in ground swimming pool to a property located in the Town of Red Cedar, please contact the Town Clerk, Cheryl Miller, at (715) 556-5034. A \$25.00 land use fee is required by the township.

*Additional fees and/or permits may also be required from the Dunn County Zoning Department. Be sure to also contact them at (715) 231-6521 before performing any work and/or construction.*

1	<p><b><u>Solid Waste/Recycling Charge:</u></b> <span style="float: right;"><b>Due by January 31, 2017</b></span></p> <p>The Town of Red Cedar is a participating municipality of the Dunn County Solid Waste/Recycling Program.</p> <ul style="list-style-type: none"> <li>Each year, the township is assessed a fee to participate in this program. Instead of adding these fees to the town's tax levy, the amount due is divided among the households located in the township. Your household's portion of the fee is shown above.</li> <li>As a member of the Dunn County Solid Waste/Recycling Program, the enclosed permit allows your residence to dispose of regular household garbage and recyclables at any Dunn County Collection Station.</li> <li>For an additional fee, you may hire a private company to pick up and dispose of your garbage and recyclables for you, but <b><u>your assessed portion of the program fee is due and payable to the township.</u></b></li> </ul> <p><i>Pursuant to Statute, if payment is not received by January 31, 2017, the Solid Waste/Recycling charge plus interest (12% annually or 1% monthly) retroactive to January 1, 2017, will be added to your next year's Real Estate Tax Bill as a Special Charge.</i></p>	\$ 55.00	\$ 55.00
Qty	<p><b><u>Dog License:</u></b></p> <ul style="list-style-type: none"> <li><b>Wis. Statute 174.05(1):</b> REQUIREMENT - the owner of a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the date the dog becomes 5 months of age, pay the dog license tax and obtain a license. <i>Dog licenses are valid as of January 1<sup>st</sup> and expire on December 31<sup>st</sup> of each year and are to be purchased on an annual basis.</i></li> <li><b>Wis. Statute 174.052:</b> REQUIREMENT - a current, up-to-date Rabies Vaccination Certificate is required before a license will be issued.</li> </ul> <p><b>Fee per dog:</b>    <b>Fixed</b>    <b>Intact/Unfixed</b>    <b>Multiple (Kennel)</b>  <span style="margin-left: 100px;">\$ 6.00</span>            <span style="margin-left: 100px;">\$ 11.00</span>            <span style="margin-left: 100px;">\$ 45.00</span></p> <ul style="list-style-type: none"> <li><b>Wis. Statute 174.05(5):</b> LATE FEES – a late fee of \$5.00 shall be assessed and collected from every owner of a dog 5 months or older, if the owner failed to obtain a license prior to April 1 of each year, or within 30 days of acquiring ownership of a licensable dog.</li> </ul> <p><i>Please note: Additional fines and penalties for failure to obtain required licensing may be assessed as follows: Wis. Stats. 174.042 (\$25.00-\$100.00 for 1<sup>st</sup> offense; \$50.00-\$200.00 for 2<sup>nd</sup> offense); Wis.
